

## Keynote Address: Developing true partnership in mission

For over a decade now Presbyterians from Kingwood have worked alongside Presbyterians from Lima, Peru, and in the last two years Presbyterians from Clear Lake and the Woodlands have joined the partnership. In the keynote address to the presbytery, the Rev. Pedro Arana-Quiroz talked about some of the lessons he's learned and how the partnership has grown from one between congregations into one between Presbyteries: the Presbytery of Juan Calvino in Peru and the Presbytery of the New Covenant.

He spoke honestly about problems facing Presbyterians in Peru. But then he spoke even more passionately about possibilities that God has put in front of them. He challenged us as Presbyterians in Texas to provide more than just monetary resources to help our Peruvian partners address their problems. "Money alone will not solve the problems we face," he said. "What we need most of all is to meet on the same ground of belief and mission as true partners and seek God's will for us."

"Our churches must grow together," he said, "because God's kingdom is growing." Then he challenged those present to be part of that growth by developing a true partnership between our Presbyteries. Such a partnership, he pointed out, will involve shared beliefs in the power of biblical preaching and teaching, love of God and world friendship, fraternity

and community.

"We must meet as friends," he said, "and then talk together about how we can share pastors, musicians, teachers, human resources, and financial resources to bring the message of the gospel to the people of Peru." A first step in that direction, he suggested, would be to form a committee of people to talk about how to develop a true partnership in mission between New Covenant Presbytery and the Presbytery of Juan Calvino.

After Pedro's address, General Presbyter Mike Cole said that he was committing himself to be a part of such a committee and invited those present to consider joining him in finding ways to strengthen the partnership that began between our two Presbyteries in 2009. What will that partnership look like in ten years? Only God knows. But if the last ten years are any guide, it will be exciting!

# First Reading of Reconciliation and Dismissal Procedure

Ruling Elder Mary Lee Going presented the proposed Reconciliation and Dismissal Procedure as a first reading from the General Council. She provided a brief overview of the document, which can be found in its entirety on the presbytery website. The procedure provides two possibilities for churches considering withdrawing from the presbytery.

Plan A is described as one of graciousness that involves a two year period of discernment that provides a procedure involving a discernment team, which includes members of the

presbytery and the congregation. At the end of the period of discernment, the church would decide to recommit to the presbytery or to be dismissed. If they complete the procedure, the church would be allowed to leave with its property while making designated contributions to the presbytery for a period of five years.

The alternative procedure applies when congregations decide not to participate in the period of discernment and intend to withdraw from the presbytery. In this case, the withdrawing congregation would

leave without its property. The proposed procedure is much more detailed and requires a complete reading to fully understand it.

Since this was the first reading of the proposal, only comments or questions for clarification were allowed during the presbytery meeting. A question was raised regarding the determination of the quorum of the congregation. The procedure requires a 2/3 vote of 30% of the active members to vote to reconcile or be dismissed. Other questions were asked and members of General Council were able to respond. Most of the speakers prefaced their remarks with comments about the document being well-written and thoughtful. A request was made for more explicit references for prayer to be included; members of the General Council agreed with this request.

Read the entire procedure and send written comments to the Stated Clerk. **A Called Presbytery meeting will be held Dec. 10, 2011 (10:00 a.m.-noon) at St. John's PC, Houston, to vote on the procedure. Amendments will be allowed at that time.**

## Commissioners defeat proposed overture to General Assembly

A proposed overture which would have added a question to the ordination questions for all ordered ministries was defeated by a vote of 90 for; 98 against.

The overture, proposed by the sessions of First Presbyterian, Bryan, and First Presbyterian, Pasadena, would have added the question, "Do you promise that, if at any time you can no longer accept the lordship of Jesus Christ, the authority of the Scripture, or the foundations of Presbyterian polity, you will, on your own initiative, make known to \_\_\_\_\_ (for teaching elders, commissioned ruling elders, and

certified Christian educators—the Presbytery; for ruling elders and deacons—the Session) the change which has taken place in your convictions since the declaration of this ordination/commissioning vow?"

Prior to the vote on the proposed overture, an amendment to change the words "the foundation of Presbyterian polity" to "the Constitution of the PC(USA)," making it consistent with the *Book of Order*, passed by a voice vote.

After brief discussion, the motion was defeated in a standing vote.

## Pastor Honorably Retired

The Rev. Carol Burgeson was granted Honorably Retired status by the presbytery.

Accepting a call from God as a teenager, Carol followed that call as a lay leader in the church and community.

Feeling a renewed sense of call during the

## Small church makes big impact


